

PRIVACY POLICY

1. Interpretation

1. **Definitions:** In this privacy policy unless the context otherwise requires:

“Crane Brothers” means Crane & Sons Limited;

“Customer” means the person or entity contracting with Crane Brothers (including the Customer’s successors and permitted assigns) for the supply of goods and services and includes any person acting on behalf of or with the authority of the customer;

“User” means a Visitor or a Customer;

“Visitor” means any visitor to the Website that is surfing, reading information, using applications or message/feedback boards on the Website; and

“Website” means the website www.crane-brothers.com (or any similar website) owned and operated by Crane Brothers from time to time.

1.2 Authorisation:

- (a) A User irrevocably authorises:

- (i) The collection and storage of the following information by Crane Brothers:

(A) The IP address of the machine when connected to the Internet and the domain name from which the User is accessing the Internet;

(B) The operating system and the browser the User’s computer uses, and any search engine the User is using;

(C) The date and time the User is visiting;

(D) The URLs of the pages the User visits; and

(E) If the User provides it, the User’s email address;

- (ii) The placement of a cookie on the hard drive of the User’s computer (if the settings of the User’s computer allows cookies to be placed).

- (b) In addition, a Customer also irrevocably authorises:

- (i) The collection and storage of contact information (and any other details required to complete sales of goods and services) of the Customer;

- (ii) Any person or corporation to provide Crane Brothers such information as Crane Brothers may require in response to any credit enquiry in relation to the Customer;

- (iii) Crane Brothers to collect, retain and use any information about the Customer, for the purpose of assessing the Customer’s creditworthiness, credit history or credit capacity, for debt collection or any

related purpose, or for marketing goods and services to the Customer; and

- (iv) Crane Brothers to disclose information about the Customer, whether collected by Crane Brothers from the Customer directly or obtained by Crane Brothers from any other source, to any other credit provider or any credit reporting agency for the purposes of providing or obtaining a credit reference, debt collection or notifying a default by the Customer.

- .3 **Privacy Act 1993:** Where the User is an individual the authorities under clause 1.2 are authorities or consents for the purposes of the Privacy Act 1993.

- .4 **Right to information:** The User shall have the right to request Crane Brothers for a copy of the personal information about the User that is retained by Crane Brothers and the right to request Crane Brothers to correct any incorrect information about the User held by Crane Brothers.

- .5 **Amendment:** Crane Brothers may change this privacy policy at any time by changing or removing existing terms or adding new ones. Changes may take the form of a completely new privacy policy. Crane Brothers will tell the User about any changes by posting an updated privacy policy on the Website. Any change Crane Brothers makes (including any new privacy policy adopted) applies from the date Crane Brothers posts it on the Website.
